Weingarten Rights... What to say...

I request Union representation. If my responses to your questions could lead to discipline or termination, or adversely affect my personal working conditions, I respectfully request that you summon my union representative. **Until my** representative arrives, I choose not to answer any questions.

When Should I Have My Union Representative Present?

In a 1975 Supreme Court decision, unionized employees were given the right to have a steward present during a meeting with management when the employee believe the meeting might lead to disciplinary action. This is known as the Weingarten decision and applies to COLT members.

Weingarten rules apply when a supervisor is questioning an employee to obtain information that could be used as grounds for discipline and possible termination. It is important to know the following:

- 1. The employee must request representation before or during the meeting.
- 2. After an employee makes the request, the supervisor has these choices:
 - a. Grant the request and wait for the union steward
 - b.Deny the request and end the meeting immediately; or
 - c. Give the employee the choice of ending the meeting or continuing without the representation.

This is always a risky option for the member to choose. It is important to remember that your supervisor is not your friend. If something you have done will reflect on his/her supervisory abilities, he/she will hang you out to dry. So, remember your Weingarten rights and keep your steward number handy.



Millions of U.S. Workers Wish They Could Join a Labor Union

U.S. labor unions and their popularity are on the rise. Some great findings have come out from the Economic Policy Institute (EPI)

A look into some of the numbers below.

- Over 60 Million U.S. workers want to join a union, but are not able to
- Workers represented by unions have decreased .3% (11.6 to 11.3).
 Because non-union job creation has outpaced union jobs, the overall percentage of the employed AND unionized is down. This may seem grim, but the labor front is actually on an upswing.
- Unions in the US have increased membership by 200,000 members between 2021 & 2022.
- The National Labor Board saw an increase in union election petitions of 53% these hopefully will eventually lead to established unions

The United States and its workforce are in the midst of a struggle. The middle class is being eaten away. History has shown us Labor Unions help.
